2025-2026 CONTRACT AND STATEMENTS OF UNDERSTANDING

Once this contract is signed, it is in force until two weeks' written notice of change or dissolution is given. In the event of dissolution, payment for the two weeks is required, regardless of the child's attendance at Children Unlimited during the notice period. Children Unlimited reserves the right to terminate this contract with 5 days' notice should it be determined that commitments and responsibilities on behalf of any child are not being met by the parent/guardian, or if the Director deems that, for any reason, the continuation of this contract is not in the best interest of the child, family, or Children Unlimited. Children Unlimited is entitled to change any of the terms in this contract, including but not limited to tuition rates, by providing the parent(s)/guardian(s) with 30 days' written notice of such changes.

I have read and understand the complete 2025-2026 Children Unlimited Tuition Policy, including, but not limited to, the following:

- A child's attendance, sickness, holidays, weather emergencies, etc., do not change weekly tuition as stated on this contract. _____ (initials)
- Changes in contracted hours can be made only if Children Unlimited has availability based upon regulated ratios, group sizes, and staffing **and** the duration of the change period is four weeks or more, *not on a weekly basis or "traded."* _____ (initials)
- Extra time may be limited. Extra time must be requested **at least one week in advance** and, if granted, is pre-paid, non-refundable, and billed at the drop-in rate. _____ (initials)
- If my child is dropped off/picked up before/after my agreed upon contracted time, a fee of \$5.00 for the first five minutes and \$1.00 per minute thereafter will be assessed per child. If I have an emergency and will be late for pick up, I will notify Children Unlimited immediately. Standard late fees will be assessed. _____ (initials)

2025-2026 CONTRACT AND STATEMENTS OF UNDERSTANDING
ACT 166 PUBLICLY-FUNDED PRESCHOOL ADDENDUM

Children Unlimited is prequalified to partner with the State of Vermont to provide publicly-funded preschool under Act 166. The Act provides for 10 hours of preschool education over the 35 weeks of the school year for all 3, 4, and 5 year old children not yet enrolled in kindergarten. Act 166 funds are paid directly to CU by the school districts. Families are not responsible for payment of these funds and, therefore, the amount is deducted from the family's tuition for those 35 weeks. The 2025-2026 school year will begin on Tuesday, September 2, 2025, and end on Friday, June 5, 2026. The total amount paid per child directly to CU by the school district for 2025-2026 is \$3,982, or \$113.77/week for the 35 weeks of the public school year. **Families are responsible for payment of the full weekly family tuition payment, less any applicable sibling discount, any time there is no Act 166 funding, including public school vacation weeks (the 5 weeks of 11/24-11/28/2025, 12/22-12/26/2025, 12/29/2025-1/2/2026, 2/23-2/27/2026, and 4/20-4/24/2026).**

Children Unlimited has entered agreements with a number of school districts to provide publicly funded preschool in the 2025-2026 school year. In order to access these funds for your child:

- Your child must turn 3 prior to September 1, 2025.
- Your child must be registered with the school district in which you reside.

Please note:

- School districts are mandated to pay only for those children residing within their boundaries and who are registered. If your family moves during the school year, both CU and the parent/guardian must notify the school district. You must register your child with the new school district in order to access Act 166 funds.
- CU is required to regularly report attendance information to the school districts. If a child is excessively absent, the district may discontinue funding for that child.
- If Act 166 funding is discontinued for a child for any reason, the parent/guardian will be responsible for payment of all monies due to CU for services rendered.

I understand that in order to receive public funds through Act 166:

- I must register my child with the school district in which I reside. _____ (initials)
- I must notify the school district and CU if I relocate to a different school district. _____ (initials)
- I will be responsible for any and all monies due to CU if the school district discontinues public funding for my child for any reason, including, but not limited to, excessive absence and/or relocation. _____ (initials)
- Children Unlimited will receive tuition for Act 166 preschool directly from the school district in which I reside. Therefore, the total amount of \$3,982 will be deducted from the total tuition due on this contract in the amount of \$113.77 for 35 weeks beginning September 2, 2025, and ending June 5, 2026. **I am responsible for payment of the full weekly family tuition payment, less any applicable sibling discount, any time there is no Act 166 funding, including public school vacation weeks (the 5 weeks of 11/24-11/28/2025, 12/22-12/26/2025, 12/29/2025-1/2/2026, 2/23-2/27/2026, and 4/20-4/24/2026).** _____ (initials)
